Prior to the expiration date of an approval, the applicant shall file the following in order to initiate renewal processing: (1)A completed set of application forms; (2)The required renewal application fee and any supplemental fees if required; and (3)A current sample of the article submitted for approval renewal produced within 90 days of submittal date. Failure to submit any of the foregoing by the expiration date will result in closing of the file.

This approval does not fulfil the requirements for approval which may be required under the Plumbing or Mechanical Code of the City of Los Angeles.
