1107 Advantage<sup>TM</sup> Grout is a non-shrink, premixed plastic-to-flowable structural grout in applications required full load bearing and stabilization such as structural grout under columns, machine bases, and base plates. Use of this product is subject to the following conditions:

- 1. The product shall be delivered to the job sites in sealed containers. In addition to the product labeling as attached, the date of manufacture and lot identification number shall be stamped on the package.
- 2. Continuous inspection by a Registered Deputy Inspector for Concrete shall be provided where design strength exceeds 2,500 pounds per square inch.
- 3. Water shall be added to the grout mix at a ratio of 8 to 9 pints per 50 pounds of grout.
- 4. Use of the grout shall otherwise be in accordance with the manufacturer's instructions, a copy of which shall be provided at each jobsite.
